The North Carolina Medical Group Management Association membership year runs from November 1st through October 31st. Prorated rates for new state members are available after June.

- Active Member: An individual employed in an executive, managerial or administrative capacity of a medical group engaged in the practice of medicine as a legal entity, sharing business management facilities, records and personnel and/or serves in an executive, managerial or administrative capacity of an integrated delivery organization that includes, as part of its primary mission, the provision of physician services and administration of physician practices.
- Faculty Member: An individual employed full-time as a faculty member at a university or college in a healthcare program.
- Affiliate Member: An individual employed by an organization that provides products and/or services to the Active members and the healthcare field.
- Student Member: A full or part time student according to the guidelines of their college or university.
- **Corporate Membership:** If you have five or more employees who qualify for NCMGMA membership (Active or Affiliate) your company could save on the cost of membership. A 10% discount, per membership, is available for companies with 5-10 applicants; a 15% discount, per membership, is available for 11 or more applicants within a company.
